**ORDER/SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 24(twenty four) point informationon **"Establishment of Cultural Centre in Old Ziro Lower Subansiri District."** during the financial year 2022-23 by the PIO, o/o the Executive Engineer (PWD), Ziro Division, Lower Subansiri District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.10.24.

This appeal was heard on 18.07.2025 wherein the appellant, Shri Tamchi Gungte and Er. Shri Radha Monty, AE-cum-APIO were present.

This Commission, upon perusal of the documents brought in by the APIO, noticed that the PIO has not furnished replies to the 19 queries. It was also noticed that the requested information/documents were not covered by any of the exemption clauses under section 8 of the RTI Act, 2005.

The PIO was, therefore, directed to furnish the documents as available in his office and also furnish suitable declaration by way of affidavit against those documents which are not available within 1(one) month from the date of receipt of Commission's order dt. 22.07.2025.

The appellant has now, vide his letter dt. 22.08.2025, informed that the PIO, despite this Commission's order failed to furnish the information even after lapse of one month and as such pleaded for action under section 20(1) of the RTI Act.

This appeal is, therefore listed again on 10<sup>th</sup> September, 2025 wherein the PIO shall be present with the left out documents.

**NOW THEREFORE**, you are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the 10<sup>th</sup> September, 2025, (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
