SUMMON NOTICE.

The 1st hearing was held on 3rd September, 2025 related to the **APIC No-304/A/2025 (Appeal)**. The PIO-cum-EE(PWD), Boleng Division is represented by Shri Jumra Hankar, ASW-cum-APIO through VC but the appellant Shri Tamchi Gungte found absent without any intimation to the Commission.

The representation has been submitted by the PIO addressed to the Commission stating that the PIO had kept ready all the requisite information for delivering to the appellant. The First appellate Authority had summoned the appellant for the three hearings, but the appellant was absent consecutively during all the hearings dated 06/02/2025 28/02/2025 and 17/03/2025.

The appellant remained absent for three hearings consecutively, so the First Appellate Authority presumed that the appellant is no more interested to pursue the appeal case. Accordingly, the appeal case was disposed of by the First Appellate Authority on dated 28/03/2025.

As per the statement made today before the Commission by the representative of the PIO, all the information sought by the appellant has already been furnished and submitted before the FAA, as the appellant was absent and could not hand over the information to him during the hearing. Covering letter of the information furnished and representation and order of the FAA is submitted today before the Commission through mail.

The appellant Shri Tamchi Gungte is directed to collect the information which is kept ready to be furnished by the PIO from the First Appellate Authority which was submitted during the time of hearing and intimate to the Commission immediately after getting the information.

If no intimation is made, the Commission will presume that the appellant is collected the information and he is satisfied and accordingly case will be heard in his absence.

The Commission adjourned the hearing and fixed next date of hearing on **03/11/2025 at 1030 hours.**
