This is an appeal under Section 19(3) of RTI Act, 2005 received from **Shri Palen Laa & Smt Yukar Yaga, C/o Jollang Near Sonam Nursery, P.O/P.S-Itanagar, Arunachal Pradesh** for non-furnishing of information by the **PIO-cum-EE, Dept. of Power Division Raga, Kamle District, Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.
