ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act. 2005. Brief fact of the case is that the appellant Shri Nabam Tai on 13.06.2023 filed an RTI application in Form-A to the PIO - CF and Field Director, Namdapha National Park & Tiger Reserve, Miao Changlang District, AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal on 14.07.2023 before the First Appellate Authority the PCCF, WL & BD, Itanagar.

Appellant again having not received the required information and decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 23.08.2023. The appellant has not attached any order of decision or response from the FAA against which appeal is preferred.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.806/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 05.09.2024. Notice of hearing dated 13.08.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 05.09.2024 the respondent PIO - CF & Field Director Namdapha National Park & Tiger Reserves is present. The appellant Shri Nabam Tai appeared.

Heard the parties present.

The appellant states that the information furnished to him is incomplete and not satisfactory. In compliance of this commission court order dated 07.06.2024 the appellant has filed a written submission dated 12.06.2024 to the PIO.

The PIO submits that most of the information has already been furnished to the appellant. The PIO has replied the appellant's written submission dated 12.06.2024 vide his letter dated 4^{th} September 2024.

After hearing and as agreed by both parties the PIO shall furnish the following additional information to the appellant within two weeks from the date of issue of this order and submit a report to this commission:

 - a) List of firms.
 - b) NIT/work order copies.
 - c) Lacation & Geo-tag
- 2) Tiger Project & CSS Scheme.
 - a) Beneficiary list for total financial amount allocated.
 - b) A copy of progress report
- 3) SADA Scheme.
 - a) Beneficiary list for total financial amount allocated.
 - b) Copy of estimate/work Order
- 4) CAMPA Scheme.
 - a) Beneficiary list with amount
 - b) Copy of estimate & work order.
 - c) Lacation & Geo-tag.

The appellant shall collect the additional information from PIO / office and submit a report to this commission.

Hearing adjourned. Next date of hearing shall be fixed after receipt of compliance report from PIO and appellant
