**Summon Notice.**

The 2<sup>nd</sup> hearing held on 19<sup>th</sup> December '2024, related to the **APIC NO. 964/2023.**  
The PIO represented by the APIO is present during the hearing but the Appellant Shri Tania June found absent without intimating the reason for his inability to attend the hearing consecutively for two times.

Heard the APIO.

The APIO stated before the Commission that he has brought the information to give it to the Appellant but Appellant found absent, and has not bothered to collect the information from the office of the PIO for which the same copy, they submitted to the Court of the Commission during the hearing. And during the last hearing the representative of the APIO intimated to the Commission that all the information(s) sought in the Form 'A' application of the Appellant are ready in the PIO's office and to collect the information by submitting the amount of Rs 10,000/- (Rupees ten thousand) only as the fees for the information(s).

The Commission on 7/11/2024 also had ordered the Appellant to collect the information from the office of the PIO but the Appellant has not collected the information(s) till date. The PIO's office has tried many times to intimate the Appellant in his mobile telephone also but the call was not reachable and twice, even while the Phone was ringing the Appellant did not answer the call.

After hearing the APIO, and going through the Form 'A' application of the Appellant, the Commission ordered:

- (i) The PIO to provide all the information as sought in the Form 'A' application of the Appellant on or before next date of hearing..
- (ii) The Appellant to collect the information(s) from the PIO's office after depositing the requisite fees of Rs 10,000/- ( Rupees ten thousand ) only from the office of the PIO on or before next date of hearing.
- (iii) To send a **summon notice** to the Appellant to be present in the next date of hearing in person or through online mode. Failing which his appeal shall **be decided ex-parte.**

- (iv) The next hearing is intimated to the Appellant. No formal notice required to be issued.
