Whereas, Shri Kocho Jomoh, the PIO –cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh had been duly served with Summon Order on 30/07/2024, and 17/12/ 2024 to appear before the Hon'ble Court of Major General Jarcken Gamlin, AVSM, SM, VSM (Retd)], State Chief Information Commissioner, Arunachal Pradesh Information Commission, on 17 /12/2024 and 11/02/2025 respectively in connection with APIC No. 355/2022 (Appeal), the PIO in question did not comply with the order of the Commission and was found consecutively absent for 02 (two) times during hearing which was held on 17<sup>th</sup> December, 2024 and 11<sup>th</sup> February, 2025. You are further directed to return this Warrant on or before the 08/04/2025 with an endorsement certifying the day and the manner in which it has been executed, or the reason why it has not been executed.
