Summon Notice.

The 3rd hearing held on **21st January, 2025** related to the **APIC-No-206/2024**. The Appellant Shri Nabam Rakesh, found absent without intimating the reason for his absent. The PIO-cum-Member Secretary, Arunachal Pradesh Forest Corporation limited, Govt. of Arunachal Pradesh, Itanagar, is represented by Shri Bishnu Sonar (UDC) during the hearing before the Commission.

Heard the representative of the PIO:

The representative of the PIO stated that the information(s) sought by the Appellant under Form-A application is ready to be furnished to the Appellant but the Appellant has not turned-up yet. After receiving Form-A application on 21st February' 2024, the PIO made a reply letter on 5th June' 2024, and sent it through speed post in the address given by the Appellant. But, the letter returned back from the post office stating that address is not found and even phone number given by the Appellant is not available.

After hearing the representative of the PIO;

The Commission ordered:

- (i) The PIO to provide all information(s) sought to the Appellant on or before the next date of hearing.
- (ii) The Appellant to collect information(s) from the office of the PIO and to intimate the Commission about complete receipt of the information(s) on or before the next date of hearing.
- (iii) Notice for the next date of hearing need not be issued to the PIO as his representative is present during the hearing.
- (iv) Notice be issued to the Appellant to be present personally or through online mode on the next date of hearing, failing which the appeal will be heard and decided ex-parte.

The Commission ordered;

The next date of hearing be fixed on 20th March' 2025 at 10:30 AM (Morning).
