ORDER

WHEREAS, in connection with the **APIC-No. 206/2024**, your personal appearance is required before the Commission on **14th November'2024 at 10:30 AM**. The **1st** hearing held on **24th September, 2024**. The representative of Appellant Shri Nabam Tai present during the hearing but the PIO found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act,2005, which is a statutory duty binding upon the PIO.

WHEREAS, The Appellant stated that till date no any information(s) has been received from the PIO.

WHEREAS Due to absence of the PIO, the Commission could not proceed the hearing of the appeal and the Commission ordered;

- (i) To **summon** the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to furnish all the information(s) to the Appellant as applied in his form 'A' application on or before next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of the RTI Act, 2005.***
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Court ordered;

The next date of hearing be fixed on 14th November, 2024 at 10:30 AM (Morning).
