**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ganpho Khusumchai, Medical Colony, Longding, Longding District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(RWD), Govt. of A.P., longding, Longding District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/05/2023 regarding **C/O Approach Road Govt. Sec. School Longding.**

**The 5<sup>th</sup> hearing was held on 15<sup>th</sup> October' 2024 (Tuesday) at 1030 hrs.**

Both the parties were present through online hybrid mode. Shri Ganpho Khumsumchai stated that pending information had not been furnished by the PIO. Er. Michi Nibo, (Mobile No:- 7005253996) who is posted as reliever of Er. Tumar Bagra, stated that the then PIO-Cum-EE (RWD), Longding now posted to EE (RWD), Capital Complex had submitted a letter to the Commission on 26/08/2024 in response to his Show Cause Notice, along with a copy of transfer order and a copy of Treasury Challan No. 23 date 22nd August' 2024 for a penalty amount of Rs. 25000/- (Rupees twenty-five thousand only) duly deposited in the Head Account "0070 OAS."

The present PIO-Cum-EE (RWD) Longding, Er. Michi Nibo informed that the requisite information was available in his office and that the Appellant could visit the office to collect the documents.

The Commission directed the Appellant to collect the documents **on 21<sup>st</sup> October' 2024 (Monday) at 11.00 hrs** in the morning office hours from the PIO's office and cautioned the PIO to be available in his office. If satisfied with the information so furnished by the PIO or dis-satisfied with the documents, the Appellant should then intimate the Commission within 3 (three) days after collection of the documents. Based on the report of Appellant the next course of action shall be taken.

If the Appellant fails to comply with the direction of the Commission, it will be assumed that the Appellant is satisfied with the information so furnished by the PIO and is no more interested in the information. The case shall be disposed of and closed without any further notice.
