ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tap Sajan on 18.01.2023 filed an RTI application in Form-A to the PIO cum DDSE Kamle, Kamle District A.P, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority cum DC, Raga, Kamle District GoAP, on 28.02.2023.

Appellant again having not received the required adequate information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 30.03.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.283/2023 (Appeal) and processed the same for its hearing and disposal.

In this hearing of the appeal on 23.08.2024 the respondents PIO is represented by APIO Shri Tamchi Taniang, DPC, DDSE Kamle District AP. The appellant Shri Tap Sajan appeared.

Heard the appellant and representative of the PIO.

The appellant submits that irrespective of order dated 25.12.2023 from this commission the required information is not yet furnished to him.

The representative of PIO produced a forwarding letter dated 23.12.2023 as proof of having furnished the information. The appellant states that the forwarding letter produced is of other RTI application by him to the same PIO containing different matter.

On perusal of this appeal case file records, it is found that above stated information forwarding letter by PIO is not pertaining to this appeal case AIPC No. 283/2023 (Appeal).

The representative of the PIO Shri Tamchi Taniang APIO cum DPC requested the appellant to visit his office for clarifications and collection of the available information.

After hearing both the parties it is hereby direct PIO to furnish information as per original RTI application in Form – A for the year 2019 – 2023 free of cost within period of three weeks from the date of receipt of this order.

The appellant shall submit a report about receipt / non receipt of the information to this commission after three weeks.

The hearing is adjourned. Next date of hearing shall be fixed in due course of time after receipt of compliance report from PIO and appellant.
