**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, for non-furnishing of information by the PIO District Forest Officer Koloriang, Kurung Kumey District Arunachal Pradesh Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The appeal is listed for hearing for the 3<sup>rd</sup> time today on 26.07.2024.

The Appellant, Shri Bamang Pacho was present but the PIO was absent today again.

The continued absence of the PIO in the hearing has been viewed seriously by this Commission. As such, this Commission is constrained to order that necessary action under the relevant provisions of RTI Act, 2005 shall be initiated against him for being disrespectful to this Commission and the RTI Act if he continues to avoid the next hearing.

The Appellant submitted that it is more than one year since he had applied for the information on 12.06.2023 but he is yet to receive the information and therefore, that the sought for information should be provided to him free of cost.

**The next date of hearing of this appeal is again fixed on 04.09.2024 Wednesday at 10:30 HRS.**

**NOW THEREFORE**, PIO, DFO Koloriang, Kurung Kumey District, Arunachal Pradesh, is hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above-mentioned date and time without fail.
