## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Teli Ango, & Mr. Nagbia Kyokam, C/o Gauhati High Court Itanagar Permanent Bench, Yupia Naharlagun, PO/PS Naharlagun, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/11/2024 regarding PMGSY Road from Ompuli to Tamang Village, Toru Circle under Sagalee ST. Constituency District Papum Pare (A.P).
- 2). The 2<sup>nd</sup> hearing was held on 8<sup>th</sup> July' 2025. Shri Gollo Tara, the PIO-cum-EE (RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh and the Appellant Adv. Teli Ango were absent.
- 3). The Commission had viewed the absence and non-performance of statutory duty by Shri Gollo Tara, the PIO-cum-EE (RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh seriously. In view of the facts and circumstances, thereby, the PIO was hereby given reasonable opportunity to appear before the commission and also directed Shri Gollo Tara, the PIO-cum-EE (RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh to SHOW CAUSE as to why penalty should not be imposed on him under section 20(1) of the RTI Act, 2005.

- 4). The next date of hearing fixed on 5<sup>th</sup> August' 2025 is re-scheduled to 12<sup>th</sup> August'2025 (Tuesday) at 1100hrs on appeal from the Appellant vide letter No. nil dated 10<sup>th</sup> July'2025.
- 5). **Therefore**, Shri Gollo Tara, the PIO-cum-EE (RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, is directed to appear in **person** before the Commission's court, failing which the Commission shall be compelled to initiate penal action under section 20(1) of the RTI Act 2005 against the PIO and issue arrest warrant under section 18(3) (a) of the RTI Act to ensure the attendance. In case the Appellant is found absent the case would be disposed of.
