Order

WHEREAS, in connection with the APIC-No. 132/2024, The 2nd hearing held on 22nd August, 2024 related to the APIC No-132/2024. The Appellant Shri Takar Jamoh present during the hearing but the PIO found absent without intimating to the Commission the reason of his absence from the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act, 2005, which is a statutory duty binding upon the PIO.

The Appellant stated before the Commission that certain information(s) given to him are mismatch, with the corollary information(s) given to him and the compiling of the information(s) are not properly done and the information(s) are incomplete for the reasons that; different donor names are mentioned for the same land .

After hearing the Appellant, and going through the reply submission of the PIO to the Appellant the Commission ordered;

- (i) The PIO to attend the hearing in person in the next date of hearing to clarify the allegation made by the appellant and to this Court to satisfy as to the fact of the information(s).
- (ii) The PIO to file a counter Affidavit / written statement to the enjoined appeal of the Appellant in the present appeal.
- (iii) To summon to the PIO to appear before the Commission in person in the next date of hearing. *Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.*
- (iv) The next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing is fixed on 1st October, 2024 at 2:30 PM (Afternoon)
