The 3<sup>rd</sup> hearing held on 26<sup>th</sup> November, 2024 related to the APIC No-115/2024. The Appellant Shri Riya Taram and his party found absent with intimation to the Commission the reason for their inability to attend the hearing due to health issues, but the representative of the PIO Taj Toko (AE) present during the hearing.

**The next date of hearing be fixed on 11<sup>th</sup> February 2025 at 1:30 PM (Afternoon)**


