11. Technical Sanction order copy (TS).
12. Work Order copy.
13. First and final bill copy.
14. Name of agency /Firm/Contractor etc
15. Furnish the Forwarding letter from AE PWD Sub-division office koloriang.
16. Estimate copy.
17. Details of payment made to the Contractor /Billing as per desire.
18. Billing challan/cash memo.
19. Furnish the details record of pay the payment made to the contractor as per tender Agreement.
20. Give the Details On What basis the payment has made to the contractor or firm in the form of cash/Cheque.
21. List of tender participants copy.
22. Furnish the tender advertisement publication in local daily news paper if any.
23. Give the Details which date tender has conducted.
24. Furnish the Staff list like computer operator, peon, driver and casual labour with Appointment Order copy and Pay rolls of above mention staffs from 2018 to till date.
25. Give the Details of Bank Statement with Account Numbers of department before/after payment made to the contractors.
26. Please furnish the details amount under salaries heads of account from 2017 to a date with list of staffs and bank account numbers as well as monthly salaries incentive money deposited as per CPWD Prescribed manual form.

Period from which information asked for: 2018 to till date.

The PIO shall furnish information to the appellant within one month from the date of issue of this order and submit compliance report to this commission. Next date of hearing shall be fixed in due course of time and intimated.*"

He states that the information is not received from the PIO in spite of order issued by the commission.

**Respondent PIO** : Absent.

**Decision:**

The commission after adverting to the facts and circumstances of the case and hearing the parties observes that vide letter dated 25.09.2024 the appellant states that the PIO has refused to comply with RTI Act, 2005 in spite of his request for the aforesaid documents. The PIO has not complied the order of this commission court dated 17.05.2024. Show cause notice order passed during the 4<sup>th</sup> hearing on 22.12.2023. It is decided to issue formal show cause notice to the PIO.
