ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Nikam Dabu on 31.12.2022 filed an RTI application in Form-A to the PIO O/o the DC, Daporijo, Upper Subansiri District AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority Cum Deputy Commissioner, Daporijo AP on 01.02.2023.

Appellant again having not received the required adequate information on decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 06.03.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.163/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 5th hearing before the Commission Court today on 26.08.2024. Notice of hearing dated 03.07.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 26.08.2024 the respondents PIO O/o the DC, Daporijo, Upper Subansiri District District A P absent. The appellant Shri Nikam Dabu appeared. The respondent PIO Shri Tanam Kyali, EAC did not attend last four hearings as well. In the 2<sup>nd</sup> hearing on 15.09.2023 the PIO was represented by Shri Tapak Rakmi DPO and submitted that the information document is ready and intimated the appellant for collection by a letter dated 08.09.2023.

Heard the appellant.

The appellant submits that he has received the information and on verification of the received documents found the furnished information is incomplete. The appellant could not specify the exact incomplete / short fall of the information furnished to him.

On perusal of this appeal case file record, it is seen that the commission has decided in its 4<sup>th</sup> hearing to proceed with penal action to PIO for his repetitive absence in the hearings. The appellant has applied RTI application in form A seeking information about MLA LAD fund of 24 - Daporijo (ST) Assembly Constituency for the period from 2019 to 2022.

The Deputy Commissioner as First Appellate Authority has not conducted statutory procedure as per RTI Act 2005 & Arunachal Pradesh Right to Information (Appeal Procedure) Rule 2005 to dispose of the first appeal filed to him on 01.02.2023 (copy enclosed). He, as higher officer in public authority who can take action on PIO, shall ensure furnishing of complete information and attendance of the PIO Shri Tanam Kyali EAC in next hearing on this appeal.

With above observation the appellant is directed to file a written submission to the PIO stating clearly and specifically about **shortcomings** in the information already furnished to him without deviation from the content in the original RTI application in Form 'A'. Upon receipt of such written submission the PIO shall furnish complete and correct information to the appellant within two weeks from the date of receipt of such written submission.

The appellant shall serve a copy of this order along with his written submission to the PIO. The appellant shall also obtain written acknowledgement from the PIO / office and submit a copy to the commission.

The hearing is adjourned. Next date of hearing shall be fixed in due course of time after receipt of compliance report this order from PIO and appellant.
