SUMMON

WHEREAS, in connection with the <u>APIC-No. 225/2024</u>, your personal appearance is required before the Commission on 9th December, 2025 at 01:30 PM. The 5th hearing held on <u>28th August</u>, 2025. The Appellant Shri Ngurang Tngpho is present through online mode during the hearing before the Commission.

The PIO-cum-EE, PHE & WS, Itanagar Division, Senki-View, Papumpare District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant;

The Appellant stated that he has approached the office of the PIO in person to collect the information(s) as ordered in the last hearing on 03.04.2025, wherein the representative of the PIO Shri Khyoda Abo, Surveyor, PHE & WS, Itanagar Division had stated that all the information(s) are ready in the office of the PIO and the Appellant may come and collect it from the office on any working day.

Viewing the absence of the PIO without reasons assigned seriously and after hearing the Appellant the Commission hereby orders as follows;

- To issue warning summons to the PIO to be present in the next hearing on the day which is given below without fail and to provide all the information(s) as applied by the Appellant on or before the next date of hearing.
- ii) The Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
- iii) No notice be issued to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 9th December, 2025' at 1:30 PM (Evening).
