**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o Post Office, Naharlagun, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P. CD-Block, Ziro-I, Ziro Circle, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 19/12/2022 regarding Expenditure and implementation of M-G NREGA schemes of entire Pistana Circle (AP).

The 7<sup>th</sup> hearing is held on 11<sup>th</sup> June, 2024 as scheduled. Shri Sylvia Koyu, the PIO-cum-BDO, Govt. of A.P. Pistana CD Block, Ziro-II, Yachuli Circle, Lower Subansiri District, Arunachal Pradesh is absent. The Appellant Shri Tania June is present.

During the 6<sup>th</sup> hearing it was clearly directed to the PIO to furnish authenticated information. The willful absence of the PIO is a matter of great regret and negligence of the duties which also amount to disrespect to the law of the land. The PIO is given last warning to appear before the Commission's court with all the document as directed during the last hearing. Failing which penal provision shall be initiated against him under section 20(1) of the RTI Act, 2005.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

**The next date of hearing is fixed on 30<sup>th</sup> July,2024 (Tuesday) at 1030 hrs.**

**Therefore,** the . Shri Sylvia Koyu, the PIO-cum-BDO, Govt. of A.P. Pistana CD Block, Ziro-II, Yachuli Circle, Lower Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
