#### ORDER

- 1. This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for nonfurnishing of information by The PIO-cum-Dy State Project Director, Govt. of A.P., SAMAGRA SHIKSHA / ISSE ,RMSA, Itanagar, P/Pare District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.
- 2. The 13<sup>th</sup> hearing held today on 24<sup>th</sup> September, 2024. Shri Tai Tader, the PIO -cum-DDSE, Govt. of A.P., Kurung Kumey District, Arunachal Pradesh and the Appellant Shri Nabam Tapak were present.
- 3. The Appellant submitted that the PIO has not furnished information for SL.NO. 3, 5, 6, 20, 21 and 22 of his form-A, Dated 07/03/2022.
- The PIO submitted that he had tried to trace out the information for Sl. No. 3 but could not find any, as the information sought are from 2014 to 2022 and there were no records available in his office. The Court advised the Appellant to ask for documents for a specific period rather than seeking information for an eight years period.
- 5. The Commission directed the PIO to trace out the information or get information from the Directorate and furnish them to the Appellant. In case information are not available or traceable, the PIO should give justifiable reasons through an AFFIDAVIT. The PIO agreed to do so.
- 6. Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.
