SUMMON

WHEREAS, in connection with the <u>APIC-No. 296/2024</u>, your personal appearance is required before the Commission on 24 July, 2025 at 10:30 AM. The 2nd hearing held on <u>29th April, 2025</u>. Both the Appellant and the PIO are absent without intimating the to the Commission, the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Due to non presence of both the parties the hearing could not proceed ahead and so hearing is adjourned for posting it on another date.

After consideration of the circumstances and pursuant to the relevant provisions of the RTI, Act, 2005, the Commission hereby order as follows;

- (i) <u>Summons</u> be issued to the PIO to attend the next date fixed for hearing in person or through online mode, failing which appropriate action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (ii) <u>Summons</u> be issued to the Appellant to attend the next date fixed for hearing in person or through online mode, failing which this appeal will be heard ex-parte.

The next date of hearing be fixed on 24th July, 2025' at 10:30 AM (Morning)
