ORDER / SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Taba Pol for denial of below mentioned information by the PIO, o/o the State Project Director (ISSE), Samagra Shiksha, Itanagar, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 06-02-2024:

1. Particular of information: Regarding Information on different sub heads under S.P.D. (ISSE), Samagra Shiksha, Itanagar, Arunachal Pradesh.
2. Details of information:
 - 11 eleven) point information against each of the following 9 (nine) sub heads :
 - (A) Students and Teacher Diary Elementary & Secondary (2018 to till date)
 - (B) Sports Elementary & Secondary (2018 to till date)
 - (C) ICT & Elementary & Secondary (2018 to till date)
 - (D) Vocational Education (tools and equipments, raw materials exposure and hands on training (2018 to till date)
 - (E) Sanitary Pad Vending and incinerator machine elementary & Secondary (2018 to till date).
 - (F) Pre Primary School Child Friendly Furniture, Out Door Play Materials (2018 to till date).
 - (G) Innovation LED (TV), Water purifier, Arun Kiran – A supplementary material to promote local language and Arun Utsav (elementary & secondary) (2018 to till date)
 - (H) Procurement of Grammer Book.
 - (I) Transportation charges for Free text books.

Period for which information is required :From 2018 to till date.

Records as emerged from the appeal are that the appellant herein, vide his application dt. 06.02.2024, had requested for the following 11 point information against the above 9(nine) sub-heads :

- (i) File Noting for approval by competent authority;
- (ii) Process of central procurement;
- (iii) Tender Book;

The appellant, therefore, did not press for the information/documents on the above 3(three) heads but insisted on the other remaining heads viz, Sl. Nos.(A) to (D) and (H) and (I) as per his application.

The APIO, Shri Kipa Kechak, on the other hand submitted that he had joined in the present posting place only about six months ago and that due to multiple number of RTI application pending in the o/o of the PIO, he is not fully aware of this particular case and therefore, requested for a copy of the RTI application dt.06.02.2024 filed by the appellant which has dully been provided to him during course of hearing. The APIO, after going through the list of points in the application on which information /documents had been sought by the appellant, pointed out that some of the documents / information, particularly those relating to schemes which were implemented in the District may not be available in the o/o the SPD, Itanagar and that he would, however, try to furnish all the information relating to those which were implemented centrally.

This Commission, upon hearing the parties and on perusal of the list of documents/information sought by the appellant, hereby directs the PIO to furnish whatever documents/information available against the remaining points to the appellant. The PIO/APIO is also directed to furnish declaration, with cogent reasons, against those documents / information which are not available with or held by the o/o PIO.

The PIO/APIO shall comply with this order within 4(four) weeks from the date of receipt of this order and report its compliance to this Commission whereafter the next date of hearing of this appeal, if required, shall be fixed and intimated to the parties.
