Summon Notice.

The 1st hearing held on 7th November, 2024 related to the APIC No-701/2023. The Appellant Shri Tamchi Gungte is present but the PIO is found absent during the hearing without intimation to the Commission for his inability to attend the hearing. which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act,2005, which is a statutory duty binding upon the PIO.

Heard the Appellant:

The Appellant stated that he has not yet received any information from the PIO and requested the Commission for summoning the PIO for next hearing.

After Hearing the Appellant and going through the Form A application of the Appellant, the Commission ordered;

- (i) The PIO to provide all the information(s) as sought in Form-A application of the Appellant on or before next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provision of RTI, Act, 2005.***
- (ii) ***To issue summon to the PIO to appear in person or through online mode. Failing which, an appropriate action will be initiated against the PIO as per the provisions of the RTI, Act, 2005.***
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 19th December, 2024 at 10:30 AM (Morning)
