**ORDER**

The 3<sup>rd</sup> hearing held on 8<sup>th</sup> July, 2025 related to the APIC No-760/2023. The Appellant Shri Tamchi Gungte is present. The PIO-cum-Project Director (PD) DRDA, Likabali, Lower Siang District is represented by his APIO Shri Nyoi Nyori, (RE) Rural Development Department during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated before the Commission that the information(s) furnished by the PIO is not satisfactorily and complete.

**Heard the APIO:**

The APIO stated before the Commission that all the works are beneficiary oriented scheme, therefore, there was no tender floated to implement the scheme.

After Hearing both the parties and going through the Form-A application of the Appellant: **the Commission hereby orders as follows;**

- i) The PIO to provide the information(s) pertaining to Serial Nos. 3, 4, 5, 6, 7, 8, 9 & 10 to the Appellant as per availability of the information(s) with the PIO and as per the work executed on the ground instead of writing N/A, on or before the next date of hearing, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- ii) The Appellant to intimate the Commission about the information(s) received completely or not, on or before the next date of hearing and to be presentd in the next hearing, failing which this instant appeal will be heard and determined ex-parte.
- iii) Notice need not be issued to both the parties as they are present in person during the hearing.
