**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Toko Nikam, Vill-Yupia-I, Po/Ps-Doimukh, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., RWD Ziro Division, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A dated 27/02/2024 regarding **C/o MRL01 Shally PMGSY Road to Taib.**

2). The Appellant, Shri Toko Nikam vide letter No. NIL Dated 12/12/2024 has informed the Commission that on the direction of the Commission vide Memo. No 259/2024 dated 19/11/2024 he visited the office of the PIO and had collected information. On scrutiny of the document he found that the information furnished were incomplete, incorrect and misleading. The information sought at Sl.no. (i), (iii), (iv), (v), (vi), (vii), (viii), (ix), (x), & (xi) of Form-A Dated 27/02/2024 were not furnished. The Appellant doubts the authenticity of information furnished against the Sl.no. (ii). The Appellant appealed the Commission to direct PIO to furnish information serially as per the sequence of Form-A dated 27/02/2024 and also provide information under AFFIDAVIT as applicable. The Appellant also appealed for site inspection with security.

4). The Commission after scrutiny of Form-A dated 27/02/2024, Memo No. APIC-259/2024/137 dated Itanagar the 21<sup>st</sup> November, 2024 and application submitted by the Appellant, directs the PIO to furnish information for Sl.no. (i), (iii), (iv), (v), (vi), (vii), (viii), (ix), (x), & (xi) of Form-A dated 27/02/2024 to the Appellant. If information were not available in his office records, the PIO may tender an AFFIDAVIT with due justification before 30<sup>th</sup> January, 2025.

5). The Appellant had not sought for Inspection in Form-A dated 27/02/2024, and hence is advised to apply fresh application to the PIO for inspection under clause (i) of sub section (j) of section (2) of the RTI Act, 2005.

6). The date of hearing is fixed on 4<sup>th</sup> February, 2025 (Tuesday) at 1100hrs.

7). Therefore, the PIO-cum-EE(RWD), Govt. of A.P., RWD Ziro Division, Lower Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail. Take notice that in case of absence on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and Section 20 of the RTI Act, 2005 shall be invoked.
