ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/PS Chimpu, Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2023 regarding the total list of project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile MSDP Scheme, Ministry of Minority Affairs Govt. of India during the financial year 2016-19.
- 2). The 5th hearing was held on 19th November, 2024 as scheduled. Shri C.J. Monnou, the PIO-cum- EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh attended the hearing through Video Conferencing. The Appellant Shri Tamchi Gungte was present.
- 3). The PIO informed the Commission that authenticated information had been furnished to the Appellant at his postal address. The PIO also submitted A/D Card with receipt signature of the Appellant Dated 02/08/2024.
- 4). The Appellant could not confirm about his receipt, but submitted that he has not been furnished with complete information as sought by him.
- 5). The Appellant had not come prepared. However, the Commission giving reasonable opportunity directed the Appellant to trace out the information furnished by the PIO and verify. If any detail was left out, the Appellant should give the specific list of the information not furnished by the PIO. The list of incomplete information should be submitted to the PIO within fifteen days from the date of issue of this order under intimation to the Commission, failing which the case shall be disposed of.

- 3). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission may initiate penal provision under section 20(1) of the RTI Act 2005 and in case Appellant is found absent the case shall be disposed of without any further notice.
- 4). The next date of hearing is fixed on 17th December, 2024 (Tuesday) at 1030 hrs.
- 5). Therefore, Shri C.J. Monnou, the PIO-cum- EE(WRD) Govt. of A.P., WRD Namsai Division. Namsai District. Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
