An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-226/2024

(Or. 5, R.3 of CPC)

Shri Tai David – VS- PIO- cum O/o the Chief Engineer (Western Zone), Deptt of Hydro Power.

<u>ORDER</u>

The 1st hearing held on <u>1st October, 2024</u> related to the <u>APIC No-227/2024</u>. The Appellant Shri Tai David and the representative of PIO present during the hearing Heard both the parties.

The Appellant stated before the Commission that he has received the information(s) requested in serial no. 9 which is utilization certificate and information(s) listed in other serial no. of his application have not been provided yet.

The PIO stated that the information(s) which are not furnished to the Appellant are with other eleven (11) Divisions/PIOs Competent Authority, and he has already written and forwarded the application to those eleven concerned Divisions /Competent Authority but till date no response have been received from the said Divisions.

After hearing both the parties and going through the form 'A' application, the Commission ordered;

- (i) The PIO to write a reminder letter to all the eleven (11) Divisions/ concerned Competent Authority to provide all the information(s) on or before next date of hearing to the Appellant. Failing which necessary action shall be initiated against them(PIO's) as per the provisions of RTI Act,2005.
- (ii) The instant PIO to provide the information(s) pertaining to serial no. 5 & 8 and pertaining to serial no. 7 may only provide name of the beneficiaries and amount of money paid on or before next date of hearing. Failing which action 25(5) shall be initiated against the PIO as per the provisions of RTI Act,2005.
- (iii) The Appellant to communicate or intimate the concerned Competent Authorities/11 Divisions/PIOs to provide him the information(s) as per the letter forwarded by the instant PIO.

Next date of hearing has been intimated to the both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 21st November, 2024 at 10:30 PM (Morning)
