ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Toko Nikam, Vill-Yupia-I, PO/PS-Doimukh, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., RWD Ziro Division, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 27/02/2024 regarding C/o PMGSY Road from Ngura Pakam to Cooperative Khach.
- 2). The 1st hearing was held on 19th November, 2024. The PIO-cum-EE(RWD), Govt. of A.P., RWD Ziro Division, Lower Subansiri District, Arunachal Pradesh was represented by Shri Sachin Jerang, APIO-cum-JE (D & P). The Appellant Shri Toko Nikam was present.
- 3). The Appellant informed the Commission that in spite of visiting the office of the PIO several times no information had been furnished till date nor had he received any communication from the PIO.
- 4). The APIO informed that communication was made to the Appellant on 28th August, 2024 asking him to collect information after paying requisite fee for the information through Treasury Challan, but the Appellant did not turn up and that the information sought by the Appellant are kept ready in the office to be furnished.
- 5). The Commission after hearing both the parties and scrutiny of the document available, directed the PIO to furnish information free of cost to the Appellant. The Appellant was directed to visit the office of the PIO on 3rd December, 2024 at 1100hrs and collect the information. After collection of information the Appellant should verify the information. In case any information was left out the Appellant should submit incomplete information list to the PIO under intimation to the Commission within ten days of receipt of information, failing which the case shall be closed and disposed of without further notice.
