**ORDER**

The 4<sup>th</sup> hearing held on **14<sup>th</sup> November, 2024** related to the **APIC No-145/2024**. The Appellant Shri Sonam Gyatso is present through online mode and the PIO-cum-Executive Engineer, PWD, Dirang Division, West Kameng District is also present through online mode during the hearing before the Commission.

Heard the Appellant and the PIO:

The Appellant stated that he has not yet received any information which he has sought from the PIO in his Form-A application under RTI, Act, 2005.
