This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, Forest Park, Near Main Powerhouse, House No. IMC-491, W-10, Itanagar, Arunachal Pradesh for non-furnishing of information by the PIO–cum-BDO Damin CD Block, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 12th time (2nd time today on 06/09/24 for BDO, Sarli as PIO) as scheduled wherein the Appellant, Shri Bamang Pacho was present but the PIO, Sarli did not turn up.

In the first hearing also the PIO did not appear.

The continued absence of the PIO in the hearing has been viewed as blatant disregard to the RTI regime and this Commission which, if continued further, shall invite appropriate action under the RTI Act.

The next date of hearing of this appeal is fixed on 9th October, 2024 at 10.30am.
