ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Buli Bhai, G-Sector, Po/Ps-Naharlagun, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P., CD Block Puchi-Geko, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 03/02/2022 regarding Expenditure and implementation under MGNREGA / supply work / pending work / new work/ sanction order / complete work.

The 4th hearing is held today on 14th May, 2024 as scheduled. Shri Taju Tama (APCS), the PIO-cum-BDO, Govt. of A.P., CD Block Puchi-Geko, Kamle District, Arunachal Pradesh and the Appellant Shri Buli Bhai are present. The PIO brought a bunch of documents claiming to be remaining information and handed over to the Appellant. The Appellant received the same and appealed the commission to give time for verification.

Considering the appeal the commission gives ten days for verification. Further, the Appellant is directed to meet the PIO and furnish the list of incomplete information if any within fifteen days from the date of issue of this order. Failing, which the case shall be disposed of in the next date of hearing. The Court is adjourned for the next date of hearing.

Both the parties are directed to appear before the Commission's court in persons on the next date of hearing. In case the PIO fails to appear the Commission shall compelled to invoke penal action against the PIO under section 20(1) of the RTI Act, 2005. In case appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant is satisfied with the information furnished by the PIO.

The next date of hearing is fixed on 25th July, 2024 (Tuesday) at 1030 hrs.

Therefore, Shri Taju Tama (APCS), the PIO-cum-BDO, Govt. of A.P., CD Block Puchi-Geko, Kamle District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
