ORDER

The 2nd hearing held on **3rd October, 2024** related to the **APIC No-220/2024**. The Appellant Shri Taba Tokur and the representative of PIO, Shri Taba Oya (APIO) present during the hearing.

Heard both the parties.

The Appellant stated that the PIO has furnished the information(s) but the information(s) are incomplete as applied in his application.

The PIO stated that, the appointment order has been already provided to the Appellant and the for joining report he will provide on or before next date of hearing and rest information(s) pertaining to serial no. 4 (2) and 4 (3) may not avail to provide to him.

After hearing both the parties, and going through the form 'A' application and the order passed in the last hearing, the Commission observed;

- (i) The PIO is misleading the Court /Commission as per the last statement stated by the PIO, he has clearly stated that all the information(s) are ready in his office, the Appellant may collect it from his office after depositing the requisite fees but today in 2nd hearing which is today the PIO is mentioning that some of the information(s) are not available in his office and he may not able to provide.
- (ii) The Commission has seriously viewed the false statement made by the PIO and ordered;
- (iii) The PIO to provide all the information(s) pertaining to serial no. 4 (1), 4(2) , 4(3), 4(7) & 4(8) to the Appellant free of cost on or before next date of hearing. ***Failing which action 25(5) shall be initiated against the PIO as per the provisions of RTI Act,2005.***
Accordingly, the PIO agreed.
- (iv) Next date of hearing has been intimated to the both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 21st November, 2024 at 10:30 PM (Morning)
