ORDER

The 2nd hearing held on **19th December, 2024** related to the **APIC-No-709/2023**. The Appellant Shri Riya Taram is present during the hearing. The PIO-cum-EE, RWD, Tawang Division, Tawang District, Govt. of Arunachal Pradesh, is present during the hearing.

Heard the Appellant and the PIO:

The Appellant stated before the Commission that the PIO may furnish only the name of the works/Scheme and exact sanctioned amount against the same works under the schemes, (SIDF)/MLA LAD/UNTIED FUND, SIDF Phase-I, during the year 2019-2020/2020-21/2021-22/2022-2023.

The PIO informed the Commission he will provide them to the Appellant before the next date of hearing or an earliest possible way.

The Commission ordered:

- (i) The PIO to provide all information(s) to the Appellant, and the Appellant to intimate the Commission about his complete or in-complete receipt of the information on or before the next date of hearing.
- (ii) The notice for next hearing date need not be issued to both the parties as they are personally present in the Court.
- (iii) The rest particulars of information(s) sought by the Appellant in his Form-A are dismissed.
