**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of information by the PIO, o/o the Divisional Forest Officer (DFO) Koloriang, Kurung Kumey District, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide application dated 12.06.2023.

The appeal is heard today on 4<sup>th</sup> Oct, 2024 as scheduled wherein both the Appellant Shri Bamang Pacho and PIO, Shri D. Basar, o/o the Divisional Forest Officer (DFO), Koloriang, Kurung Kumey District AP are present.

During the course of hearing the PIO has submitted the document (creation of ANR Plantation at Patu and creation of artificial plantation at Namya Dampo) to the appellant.
