This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nibo Pao and others for non-furnishing of below mentioned information by the PIO o/o the DFO, Daporijo Forest Division, Upper Subansiri District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 19-08-2024

**A) Particular of information:** Implementation of AP State CAMPA funds for DFO, Daporijo Forest Division, Upper Subansiri District (A.P) from 2014 to 2024 and all kinds of reserved forest notifications in Daporijo Forest Division.

**B) Details of information required:**

- (i) Project wise chart showing the enumeration of trees, species, and firth wise volume in respect of diversion of forest lands.
- (ii) Project wise statement showing number of trees volume and valuation of trees in respect of diversion of forest lands.
- (iii) Project wise detail estimates for departmental timber operation against extraction of trees in respect of diversion of forest lands.
- (iv) Project wise abstract of Royalty and Departmental timber operation.
- (v) Project wise detail estimates for creation of compensatory afforestation for diversion of forest lands with maps
- (vi) Project wise certificates from the competent authority regarding suitability area identified for compensatory afforestation.
- (vii) Project wise site inspection reports.

- (viii) Year wise amount receipts under AT state CAMPA from the office of PCCF, department of Environment, forest and Climate change, Itanagar, Govt. A.P.
- (ix) Year wise payment made with cheque counterfoils, money receipts and bank statement of DDO/DFO Daporijo forest Division and
- (x) All types of Reserved Forest Notification in Daporijo forest division with minute of meeting and agreement copies if any.
- C) Period for which information is required: 2014-2024
