ORDER

The 1st hearing held on 28th November, 2024 related to the APIC-No-1074/2023. The Appellant Shri Nabam Sonu found absent without intimation to the Commission during the hearing. The PIO-cum-EE, PHE & WS, Department, Raga Division, Kamle District, Govt. of Arunachal Pradesh, also found absent during the hearing without intimating to the Commission the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties. Govt. of Arunachal Pradesh is found absent for three consecutive hearings.

- Notice also be issued to the Appellant to appear in person or through online mode (iii) before the Commission in the next date of hearing, failing which his appeal will be decided, ex-parte.
