ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act 2005. Brief fact of the case is that the appellant Shri Riya Taram on 02.08.2022 filed an RTI application in Form-A to the PIO cum EE, PHE & WS Kodukha, Upper Subansiri District AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority cum SE PHE&WS, Yachuli Circle, Lower Subansiri District, Itanagar on 09.09.2022.

Appellant again having not received the required information and decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 27.10.2022. The appellant has not attached any order of decision or response from the FAA.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.711/2022 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 7th hearing before the Commission Court today on 19.08.2024. Notice of hearing dated 27.06.2024 were served to FAA, PIO and the Appellant.

In this hearing of the appeal on 19.08.2024 the PIO is represented by Shri Lemin Ete, JE, PHE & WS Kodukha, Upper Subansiri PWD Roing District A.P. The appellant Shri Riya Taram appeared.

Heard the parties.

The appellant submits that no information is furnished to him by the PIO in spite of order of this commission court.

Shri Lemin Ete, JE representative of PIO has brought the information in the court and handed over the same to the appellant. The appellant has received the documents and agreed to examine the information before acceptance for disposal of this appeal.

The commission after hearing both the parties hereby directs the appellant to examine the information document provided to him. If there is any shortcoming / incorrect in the information furnished, the appellant shall file a written submission to the PIO clearly stating the shortcoming / incorrect item of information as sought in RTI application in form A. He shall obtain acknowledgement receipt of such written submission from the PIO / office. A copy of such acknowledgement receipt obtained shall be submitted to this commission before next date of hearing.

The hearing is adjourned. Next date of hearing shall be fixed in due course of time after receipt of compliance report from PIO and appellant.
