SUMMON

WHEREAS, in connection with the **APIC-No. 340/2024**, your personal appearance is required before the Commission on **10th April, 2025 at 10:30 AM**. The **1st** hearing held on **6th February, 2025**. The Appellants Shri Riya Taram and others are present during the hearing. The PIO-cum-EE, PWD, Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant:

The Appellant stated before the Commission that he has not got any information(s) from the office of the PIO till now, and no correspondence from the office of the PIO.

Due to non presence of the PIO the hearing could not proceed ahead and so Appeal is adjourned for posting it on another date.

After Hearing the Appellant, and after consideration of the circumstances and pursuant to the relevant provisions of the RTI, Act, 2005, the Commission hereby orders as follows;

- (i) **Warning Summons** be issued to the PIO to be attend the next date fixed for hearing in person or through online mode, failing which an appropriate action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- (ii) Next date of hearing has been intimated to the Appellant. No formal notice need to be issued to the Appellant, as he is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 10th April, 2025' at 10:30 AM (Morning)
