ORDER

The 1st hearing held on 3rd December' 2024, related to the APIC No-750/2023 (Appeal). The Appellant Shri Dongru Tania and PIO-Cum- EE (UD & Housing) Govt. of, Arunachal Pradesh present during the hearing.

Heard both the PIO and Appellant:

The Appellant stated before the Commission that he has not received any information from the PIO, as sought in his form 'A' application till date.

The PIO stated before the Commission that he has intimated to the Appellant and also written a letter dated 3/7/2023 to collect the documents from the PIO's office, after paying requisite fee of Rs 1318/- (Rupees one thousand three hundred eighteen) only but the Appellant did not collect the information till today.

After hearing both the parties and going through the form 'A' application. The Commission ordered;

- (i) The PIO to provide all the information to the Appellant as sought in his form 'A' application, and the Appellant to collect the information after paying the requisite fees from the PIO's office.
- (ii) The Appellant after going through the information received, intimate the Commission whether he has received full information or not on or before next date of hearing. The Appellant Dongru Tania also stated before the Commission that Shri Yukar Takar has withdraw his name for being one of the Appellant, and hence Dongru Tania will only be the party as the Appellant in the instant appeal.

The Commission ordered:

The next date of hearing be fixed on 13th February 2025 at 10.30 AM

Next date of hearing has been intimated to both the parties. No formal notice required to be issued.
