SUMMON

WHEREAS, in connection with the <u>APIC-No. 76/2025</u>, your personal appearance is required before the Commission on 31^{st} July, 2025 at 10:30 AM. The 1^{st} hearing held on 6^{th} <u>May, 2025'</u> related to the <u>APIC No-76/2025</u>. The Appellant Shri Tamchi Gungte is present. The PIO-cum EE, RWD, Ziro Division, Lower Subansiri district, Govt. of Arunachal Pradesh, found absent during the hearing without intimation to the Commission for his inability to attend the hearing. which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act,2005, which is a statutory duty binding upon the PIO.

Heard the Appellant;

The Appellant stated before the Commission that his first appeal is being dismissed in the court of First Appellate Authority (FAA) because he could not attend the hearing before the FAA, and therefore, he preferred to appeal in this Commission as second appeal.

After hearing the Appellant the Commission observes;

In the absence of the PIO the facts of the appeal could not be discussed, and hence, the hearing be fixed on another date.

And the Commission hereby orders as follows;

- (i) Send summons to the PIO to attend the hearing on the next date of hearing in person or through online mode, failing which necessary action will be initiated against the PIO under the provisions of RTI, Act, 2005.
- (ii) Notice for the next date of hearing need not be served to the Appellant as he is personally present during the hearing before the Commission.

The next date of hearing be fixed on 31st July, 2025' at 10:30 AM (Morning).
