SUMMON.

The 4th hearing held on 30th January, 2025 related to the APIC-No-216/2024. The Appellant Shri Lenzig Pertin is present through online mode. The PIO-cum-DLRSO, East Siang District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant:

The Appellant stated before the Commission that the office of the PIO provided him information(s) pertaining to Govt. correspondence for the land allotment at Gumin Nagar, Pasighat, for the information(s) pertaining to the list of the persons allotted land at Gumin Nagar for the year 2003 only and the correspondence, letter(s) for allotting land for the plot No. 101 & 227 and the master plan map are not legible and requested the Commission for directing the PIO to provide legible copy the same and the list of land allottees from 2003 to 2024 .

The Commission observed:

Due to the absence of the PIO hearing could not be proceeded ahead with and adjourned the appeal for a next date.

The Commission ordered:

- (i) The PIO to provide clear and legible copies/information(s) pertaining to Govt. correspondence for the land allotment at Gumin Nagar, Pasighat, from 2003 to 2024 and the master plan map for Gumin Nagar, Pasighat, East Siang District, on or before the next date of hearing

- (ii) Notice need not be issued to the Appellant as he is personally present during the hearing.
- (iii) Summon be issued to the PIO to be present on next date of hearing in person or through online mode, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.

The Commission ordered;

The next date of hearing be fixed on 3rd day of April' 2025 at 10:30 AM (Morning).
