SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tall Yitor, for non-furnishing of information by the PIO DFO Daporijo Forest Division Upper Subansiri District Govt. of Arunachal Pradesh. as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide application dated 08.06.2023

The appeal is heard for the fifth time today on 4th of Oct, 2024 as scheduled wherein the Appellant Shri Tall Yitar is present but the PIO, o/o the DFO, Daporijo Forest Division, Upper Subansiri District AP is absent.

As informed by the appellant during the last hearing he had collected the left out information from the PIO which was handed over to his relative by the PIO. However, the appellant submitted that the information so furnished is incomplete and also that the copy of AoP for 2020-2021 on CAMPA is not legible and therefore he requested for direction to the PIO to provide complete information as he had sought for vide his application in form 'A' and also legible copy of the AoP.

This Commission perused copy of the AoP and it is found that the copy of AoP is, indeed, not legible one. Therefore, this Commission directs the PIO to furnish the complete information and legible copy of the AoP. The PIO is also directed to furnish affidavit in respect of those documents which the PIO is not able to furnish. The appellant is also directed to submit written statement mentioning the deficiencies / shortages of the information which was furnished by the PIO within 1st Nov. 2024. The PIO is also directed to appear in person in the next date of hearing without fail failing which this Commission shall be constrained to initiate penal action under the relevant provisions of RTI Act 2005.

The next date of hearing is fixed on 1st November, 2024 at 02.00 pm.

NOW THEREFORE, PIO, DFO Daporijo, Forest Division, Upper Subansiri District, Govt. Of Arunachal Pradesh is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above-mentioned date and time without fail.
