**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ram Veo, C/o Advocate Nayam & Associate, Itafort Shopping Complex, Itanagar for non-furnishing of information by the SPIO-cum-EE(PHE & WS), Govt.A.P., Yingkiong Division, PO/PS Yingkiong, District Siang, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/02/2023 regarding Compensation of water supply or damage estimate / amount of Dite-Dime-Migging Road Package-I to package-IV, for construction / Improvement of Road to NHDL Specification.

2). **The 6<sup>th</sup> hearing is held today on 2<sup>nd</sup> July, 2024 as scheduled.** Er. Rajen Tayeng, the PIO-cum-EE(PHE & WS), Govt.A.P., Yingkiong Division, PO/PS Yingkiong, District Siang, Arunachal Pradesh is represented by Er. Kaling Paron, AE (PHE & WS), Sub- Division, Yingkiong. The Appellant Shri Ram Veo is present. The representative of the PIO in compliance with the direction of the Commission made on 30<sup>th</sup> April, 2024, brought a bundle of documents and handed over all the hard copies to the Appellant. The Appellant received the same and appealed the Commission to grant time to study and verify the documents so furnished by the PIO. The Appellant assured that he will intimate about his findings directly to the PIO with intimation to the Commission within 20(twenty) days.

3). The Commission giving reasonable opportunity directed the Appellant to verify the documents and intimate the PIO within twenty days i.e. on or before 22<sup>nd</sup> July, 2024. In case any information sought at Form-A is not furnished the Appellant should furnish the list to the PIO. The PIO should furnish those information within thirty days from the receipt of the list form the Appellant. So, that the case can be disposed of in the next date of hearing. The court is adjourned for the next date of hearing.

4). Both the parties are directed to appear before the Commission's court in persons on the next date of hearing. In case the PIO fails to appear the Commission shall be compelled to invoke recommendation of disciplinary action against the PIO under section 20(2) of the RTI Act, 2005. In case appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant is satisfied with the information furnished by the PIO.

**The next date of hearing shall be intimated in due course of time.**
