**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Sama Bagang, Forest Colony quarter Type-I, Chimpu Police Station, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (E), Capital Electrical Division, Department of Power, Itanagar, District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 15/05/2023 regarding 11 KD dedicated feeder along with distribution transformer sub-station and sitting up power for Chief Minister Bugalow, State Guest House and Banquet Hall at Niti Vihar, Itanagar. Amounting to Rs. 350.00 (three crore fifty lakhs).

2). The 2<sup>nd</sup> hearing is held today on 25<sup>th</sup> July, 2024 as scheduled. Shri Tadar Rade, the PIO-cum-EE (E), Capital Electrical Division, Department of Power, Itanagar, District, Arunachal Pradesh and the Appellant Shri Sama Bangan are present.

3). The PIO has submitted that he has furnished information related to APIC-996/2023 on 04/06/2024 and information related to APIC-997/2023 was prepared and kept ready to be furnished on 10<sup>th</sup> July, 2024 and invited the Appellant to collect the same, but the Appellant denied to receive as he could not comply with the direction of the Commission which was to be supplied within twenty five days from the date of issue of the order of the 1<sup>st</sup> hearing.

4). The Appellant has submitted that the information received on 04/06/2024 are incomplete and he will intimate about the incomplete information to the PIO for the supply of complete information.

5). The information related to APIC-997/2023 is brought in the court room and handed over to the Appellant. The Appellant received the information and appealed the Commission to give time for verification.

6). The Commission considering the appeal of the Appellant, giving reasonable time of fifteen days directed him to verify the information and intimate to the PIO if any information are not supplied. The Appellant is also directed to get all information from the PIO before the next date of hearing for disposal of the case. The PIO is also directed to act diligently and expeditiously for the disposal of the case.

7). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

**The next date of hearing shall be fixed and intimated in due course of time.**
