An Appeal Case U/S 19(3) of RTI Act, 2005

SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Samen Romat for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, RWD, Hawaii, District: Anjaw, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 13.09.2024.

A) Particular of information: Regarding recent repair & renovation work porter track including FSBS in between Samdul to Khrojong Pass (Burma border) and repair and renovation work of FSBS, track at Bhaw, churul, Rounghat, Kawal and Kulung river including log bridge in between Samdul to Khrojong pass.

B) Details of information required:

1. Name of contractor;
2. Name of the agencies;
3. Name of the scheme with details;
4. Numbers of the Log bridge constructed with details;
5. Numbers of the FSBS bridge maintenance in between Samdul to Khrojong pass;
6. Completion certificate of the above works;
7. List of the contractors;
8. Whether payment has made against contractor, if so, provide cheque number with details;
9. Detail project report (DPR) for the said work;
10. Certified list of all maintenance and repair work carried out through contractual agencies or by the public authority itself;
11. Certified copy of all works order issued and contracts awarded, along with the schedule of work, sanctioned detailed estimate and approved drawing / sketch for each maintenance and repair work;
12. Certified copy of measurement book used to record measurement with respect to each work order/contract and approval granted during the specified period;
13. Certified copies of the latest running account bills or final bills paid to the contractors for each of the maintenance on repair works;

14. Detailed information on any penalties imposed on contractors/agencies for substandard works, in different performance or incomplete execution of works during the specified period;
15. Certified list of all officers and supervisors responsible for executing monitoring and recording measurement books for each maintenance and repair work with specified period;
16. Certified list of all maintenance and repair work carried out during the specified period, including the respect of performance guarantee amount held by your public authority for each work order or contract awarded to contractors;
17. Certified copy of the note sheet and order of the competent authority to release the performance guarantee deposit amount held by your public authority for each work order/contract during the specified period;
18. Certified copy of all inspection notes/reports issued by the officer in charge and supervisors in charge for the said works;
19. Certified copies of all manuals or documents showing the schedule of inspections required to be carried out by the officer and supervisors of your public authority with respect to the conditions and maintenance work;
20. The names, designations, office address and telephone numbers of the officers and supervisors responsible for executing monitoring and supervising the above maintenance work;
21. Materials at site (MAS), if issued?
22. M.B. No if payment has been prepared?
23. Certified copy of the sanction order?
24. Period from: 2020-24.

Brief facts emerging from the appeal:

The records in the appeal disclose that the appellant had requested the PIO for the aforementioned information but failed to obtain the same which prompted him to file appeal before the First Appellate Authority, the S.E (RWD), Govt. of A.P, Namsai Circle, Namsai under section 19(1) of the RTI Act vide his Memo of Appeal dt.22.10.2024. The appellant, however, failed again to obtain the information/documents from the PIO. Hence, he preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act vide his Memo of Appeal dt.17.12.24.

This appeal was listed for hearing for the 2nd time today on 14.05.2025, the 1st time being on 11th April, 2025 when neither the Appellant, Shri Samen Romat nor the PIO, o/o the E.E. (RWD), Hawai, Anjaw District Anjaw appeared.

In the absence of both the parties the hearing could not be conducted. The Commission viewed the absence of both the parties seriously and warned the appellant to be present in the next hearing on **14th May, 2025** failing which it was made clear that the appeal will stand disposed of and closed as not being interested by him.

In today's hearing the appellant Shri Samen Romat is present through VC but the PIO is absent without any intimation. The continued absence of the PIO or his representative has been viewed seriously by this Commission.

Since the hearing of the appeal could not be conducted due to absence of the PIO, the appeal is listed again on 04.06.2025 wherein the PIO must be present so as not to compel this Commission to initiate penal action under section 20 of the RTI Act.

You are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC in person on the 4th June, 2025 (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.


NOW THEREFORE, take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
