**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by Shri Pokter Rime, the PIO -cum-DDSE, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.

2). The Appellant vide letter no. nil dated 08/07/2025 informed the Commission that the PIO has not furnished information for Sl.no. 1, 2, 5, 7 & 16 as sought by him in the Form-A dated 07/03/2022. Also, the PIO has not authenticated the information provided.

3). The Commission therefore decides to have a fresh date of hearing.

**4). The date of hearing is fixed on 19<sup>th</sup> August'2025 (Tuesday) at 1100hrs.**

5). Both the parties are directed to appear before the Commission's court on the date of hearing without fail. If the PIO is found absent the Commission may initiate penal action under subsection (1) of section (20) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of.
