HEARING NOTICE

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Yiter Lombi & Yidik Lombi, Library Guwahati High Court, Itanagar Permanent Bench, Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-Project director, DRDA, Leparada District, Govt. of Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 12/11/2022 regarding **Pradhan Mantri Awaas Yojana (PMAY-G) Under Basar, Leparada District.**

The 7th hearing is held today on 11th June, 2024 as scheduled. Shri Ejum Angu, the PIO-cum-Project director, DRDA, Basar, Leparada District, Govt. of Arunachal Pradesh and the Appellant shri Yiter are absent.

In view of absence of the Appellant the case could have been disposed of but due to absence of the PIO the Commission could not do so.

The Commission viewed seriously the absence of the PIO without any prior intimation to the Commission and willful absence from performing the statutory duty. For the gross violation of provisions of the RTI Act, the respondent Shri Ejum Angu, the PIO-cum-Project director, DRDA, Basar, Leparada District, Govt. of Arunachal Pradesh is **SHOW CASUED as to why penalty under section 20(1) of the RTI Act, 2005 should not be imposed on him.** The respondent is also directed to send his written submission along with all the supporting document upon which he chooses to reply during the hearing at least seven days prior to the actual date of hearing. The PIO is also directed to furnish remaining information as directed in the 6th hearing held on 26th March, 2024.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 30th July, 2024 (Tuesday) at 1030hrs.

Therefore, Shri Ejum Angu, the PIO-cum-Project director, DRDA, Basar, Leparada District, Govt. of Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
