## **SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, for non-furnishing of information by the PIO –cum-EE, PWD Pakke Kessang Division, Pakke Kessang District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17.04.2023.

This appeal is heard for the 6<sup>th</sup> time today on 18<sup>th</sup> October, 2024.

The appellant, Shri Riya Taram is present and the APIO, Shri Gumuk Nabam, AE o/o the E.E. (PWD) Pakke Kessang, Pakke Kessang District, AP is also present.

As directed by this Commission in its order dated 24<sup>th</sup> July 2024, the APIO has brought all the documents as sought for by the appellant but since the documents are not indexed properly as 'SIDF' and 'CMCSRP' and are mixed up, the appellant refused to receive the same and requested this Commission to direct the APIO to furnish the information on both the 'SIDF' and 'CMCSRP' in a systematic manner and year wise and with proper Annexure separately for the 'SIDF' and 'CMCSRP'.
