**Summons**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, for non-furnishing of information by the PIO –cum-EE, (PWD), Yingkiong Division, Upper Siang District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The hearing of this appeal was scheduled for the 6<sup>th</sup> time on 24.07.2024. But neither the appellant nor the PIO or his representative attended the hearing. The parties did not attend the 5<sup>th</sup> hearing fixed on 19.06.2024.

In the 4<sup>th</sup> hearing held on 22.05.2024 wherein the appellant was absent but Shri Rajendra K.N, Junior Estimator, the representative of the PIO, was present, this Commission directed the representative of the PIO to hand over the authenticated / Certified copies of the documents to the appellant who was to go through the documents so provided to him and inform his satisfaction or otherwise to the Commission on or before the next date of hearing on 19.06.2023. However, as recorded above and in the order sheet of the hearing dt.19.06.2023, the parties did not turn up for the hearing. In today's hearing also the parties failed to turn up, although the representative of the PIO informed just before the commencement of the hearing of his inability to attend the hearing due to road blockade.

The continued absence of the parties, particularly, the appellant, in the hearings fixed, has been taken seriously by this Commission and is of the view that the appellant is no longer interested in the information he had sought and accordingly, inclined to dispose and close the appeal as such. However, a last opportunity is afforded to the parties to comply with the direction of this Commission as contained in the order dt.22.05.2024 before the next date of hearing failing which the appeal shall be disposed of and closed for once and for all as being not pursued/pressed for further intervention.

**The next date of hearing of this case fixed on 28/08/2024 Wednesday at 10.30 HRS.**

**NOW THEREFORE**, the PIO-cum-EE, (PWD), Yingkiong Division, Upper Siang District, AP is hereby again summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above date and time without fail.
