**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Taning Dodum for non-furnishing of information by the PIO, o/o the Divisional Forest Officer (DFO), Roing Forest Division, Dist. Lower Dibang Valley (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 24.07.2024.

The appeal was heard on 22<sup>nd</sup> Nov., 2024 wherein the appellant Shri Taning Dodum was present in person and the PIO, Shri Hibu Tana attended the hearing through VC.

In the said hearing the PIO submitted that the sought for information is ready for handing over to the Applicant/appellant. He also submitted that the information was, in fact, sent to the appellant at his residential address- Chimpu, Itanagar through the Speed Post which was duly delivered as per the tracking record. The appellant, however, responded that he did not receive the documents.

This Commission, upon hearing the parties, and considering that the sought for information/documents are ready, directs the PIO to send the duly certified documents to this Commission Office within 1(one) week from today through a responsible officer and the appellant shall collect the documents and intimate to this Commission of his satisfaction or otherwise on the documents so furnished by the PIO within one week from the date of receipt of the documents whereafter the date for next hearing, if required, will be fixed and intimated to the parties.

As directed, the appellant, it is observed, had collected the documents from the PIO and had gone through the same and the appellant vide his letter dated 11<sup>th</sup> Dec. 2024 addressed to the Commission has now intimated that he is not satisfied with the documents furnished by the PIO as the furnished documents are incomplete. He, therefore, pleaded this Commission for direction to the PIO to furnish the complete information.

This Commission also holds that the documents as sought for by an applicant ought to be furnished properly and to the full satisfaction of the applicant so as to comply with the mandate of the RTI regime and hence, this Commission directs the PIO to furnish the complete information sought for by the appellant as sought for vide the applicants application on or before 29.01.2025
