## WARNING SUMMON

WHEREAS, in connection with the APIC-No. 21/2025, your personal appearance is required before the Commission on 25<sup>th</sup> November, 2025 at 01:30 PM. The 2<sup>nd</sup> hearing held on 19<sup>th</sup> August'2025. The Appellant Shri Sangkung Jonah found absent during the hearing and PIO-cum DDEE,, Itanagar Govt. of Arunachal Pradesh, also absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both the parties and hereby orders;

- warning summon to the PIO-cum-Director of Elementary (i) To Send Education(DDSE )Itanagar, Govt. of Arunachal Pradesh to attend the hearing on the next date of hearing without fail, failing which necessary action as provided by the RTI, Act, 2005 shall be instituted against the PIO.
- (ii) The PIO to provide all the information(s) which are available in the office of the PIO on or before the next date of hearing.
- To send summons to the Appellant to be present on the next date of hearing, failing (iii) which the instant appeal shall be heard and determined, ex-parte.
- (iv) Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission hereby orders;

The next date of hearing be fixed on 25th Nov' 2025' at 1:30 PM (Evening)
